CRoW Act Access

The Countryside and Rights of Way (or CRoW) Act was passed in 2000 and came into effect in the North York Moors area in May 2005. It gives a general right of access for walkers for open-air recreation on 'access land'. This is known as 'open access' i.e. where there is right to use a whole area of land (within defined mapped boundaries), rather than just along linear rights of way. Sometimes this is known as the 'right to roam' but this can be a misleading description because it is by no means a completely free licence to roam everywhere.

CRoW Act access land is made up of registered common land and 'open country' (land classed as mountain, moorland, heath or down). Within the National Park, this amounts to 23,598 ha of registered common land and 24,375 ha of open country. In addition, some Forestry Commission woodland has been voluntarily dedicated as access land.

Access land is shown on recent (post-2005) Ordnance Survey Explorer maps in a yellow colourwash. However, some places are excluded from access rights even though they may be depicted as access land on maps. Such places include buildings, private gardens, land

within 20 metres of a dwelling, active quarries, golf courses, airfields, railways, military land, land in operational use by statutory undertakers and telecommunications systems, ploughed land.

CRoW Act access rights allow recreational activities on foot, including walking, picnicking, bird-watching, climbing, and running. It does not apply to access on horse, bicycle or any vehicle. There are a number of activities which are not allowed - such as camping, swimming, lighting fires, metal detecting, fishing, hunting, hang-gliding, organised games, commercial activities.

CRoW Act access land may be closed or otherwise restricted. Such restrictions do not affect rights of way over the land, which remain open and unrestricted.

Most owners of grouse moors in the National Park have used their right to ban dogs from open access on grouse moors. In open access areas where dogs are allowed, they must be kept on a short lead between 1st March and 31st July (i.e. the main bird breeding season).

All moorland open access areas of the National Park are closed at times of exceptional severity fire risk.

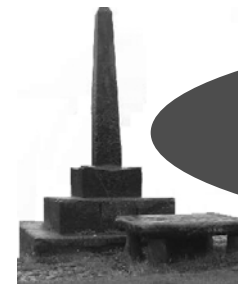
Landowners and tenants have the right to close the land for any reason for up to 28 days per year (but there is a limit on use of closures on summer weekends). In the North York Moors these closures have mostly been used on grouse moors in late May to the end of June during the period when grouse chicks have hatched and are particularly vulnerable to disturbance.

Landowners and tenants can apply for further closures for land management or public safety – but none have done so in the North York Moors.

Open access in forestry areas may be closed during felling operations.

Land can also be closed or otherwise restricted by the National Park Authority for public safety or nature/ heritage conservation. However, careful planning and management of access has so far meant that it has not been necessary to make restrictions for these reasons.

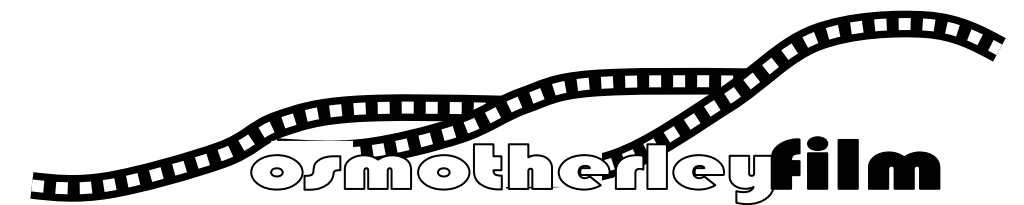

Osmotherley Area Parish Council

Osmotherley Area Parish Council have held a number of meetings during March with the most significant being a public one to appeal against the proposed closure of the Village's Post Office. In addition there has been the monthly Council meeting which was able to ratify a resolution that stated *"A full time Post Office is needed to serve the needs of the community of the Osmotherley area and that a hosted service of 8 hours per week will not provide for the needs of this community"*.

This public meeting was held in the Village Hall which was full to capacity and was attended by representatives of the Post Office, Postwatch and the National Park. Post Office opened by stating their case based solely on financial criteria and also stated that they had consulted with all of the local authorities. This last statement was categorically denied by Andy Wilson, the Chief Executive of the North York Moors National Park whose authority had not received any consultation documents whatsoever, his comments to the meeting were greeted with spontaneous applause for the manner in which he was able to attack the lack of fact and evidence put forward by Post Office.

Many others speakers from the floor were themselves in business and stated that they will seek an alternative service particularly to send packages rather than travel to Northallerton or rely on an arbitrary hosted facility Others highlighted the lack of knowledge held by Post office of customers' requirements and made it known that an alternative service to that already in place would not meet their needs. The resolution was carried unanimously and thanks are due to Mike Thomsett and the appeal team for presenting such a well researched and factual document to present to Post Office Ltd and it is now hoped that there will a positive outcome.

The monthly PC meeting heard how the Chairman had with the assistance of a few others obtained the services of Aldersons of Worsall to dig into the culvert near the bus shelter and were able to tackle the water leak problem. You may already have noticed that water no longer pours down the road. There is still some tidying up to do as the refilled trenches settle down so please be patient with us as this will take some time. Thanks to residents for parking elsewhere while the work was carried out. We will now try to find a solution to a similar problem near the Pinfold. This is almost certainly due to the weight of traffic causing the culvert to collapse under the road and will mean working with NYCC Highways to find and repair the fault so please bear with us. Another area of water damage is visible on the Village Green about 20 meters above the War Memorial and because this would appear to be of sewage rather than of water the householders have been asked to consider if their pipe work is damaged.

A planning application has been received seeking permission to put in a hard standing area on The Lords Waste, an area of grass which is not owned by the applicant. Members agreed that this should not be allowed but a fall back arrangement could be considered using a grasscrete type material which would permit grass to grow through it which would be considerably less unsightly than the cobbles nearby. A further application to build a 5 bay stable block off Clack Lane was discussed in great detail and was subsequently supported when it became clear that it was only for private use to house "driving" horses and their tack and that it would not result in an increase in traffic volumes.

Work should start in early summer to effect a permanent repair to the Ellerbeck crash barrier and also to put additional bollards at the edge of the footway up North End. Both of these safety features are to be welcomed. Problems still exist in Thimbleby with heavy traffic cutting up the verges and this is to be taken up with Highways to try to reach a solution.

Future events in the area include the Summer Games at the beginning of July and an offer of assistance from the Royal Dragoon Regiment is being followed up in the hope that they could assist on the day. Remembrance Day falls on the 9th November this year and the Parish Council agreed to lay a wreath at the Service. A date was agreed for the Annual Assembly which has been booked to be held in the Village Hall on 22nd May.

Osmotherley Pre-School

We have been recognised by the Local Education Authority as a 'highly effective setting'. Only 46 out of 298 settings in North Yorkshire have been awarded this. We are very proud and would like to express our thanks to everyone involved in making pre-school a success. Osmotherley Pre-School currently have places available every morning 9.30-1.30am for children from 2yrs old. A lunch club is also available.

Free Bicycle Health Check and Postcode Marking

Following the success of last year's bike clinic held in the Village Hall, we will, as promised, be holding a repeat event.

Thinking that now the days are getting longer, the weather fairer, you still haven't lost those 'Christmas pounds' and want to get out on your bike a bit more? Give it a once-over by a professional and get it security marked at the same time by bringing it to the Village Hall on Monday 7th April between 6.30 and 8.30pm.

An expert from Cowley Cycles in Northallerton has agreed to be on hand to give your bike a free health check. If it needs work and can be done in a reasonably short time it will be done there and then. If not, a quote for repairs will be given and free transport will be arranged to take the bike to Northallerton and return it to Osmotherley, or your house if possible, within a few days (subject to numbers).

Whilst you're there, North Yorkshire Police will be on hand with their postcode marking kit. In the event of you having your bike stolen, postcode marking will make it much more likely that you'll get it traced back to you and returned. (Under 18s will need a parent/guardian's signature as consent for postcode marking).

Parish Plan – Wildlife Group

After a delayed start a working group chaired by Alan Turner is up and running to implement actions arising from the Parish Plan under the broad heading of Natural Environment. A survey of footpaths is well underway with Pat Duggan covering those inside the National Park, Alan Turner covering those outside the Park and Carolyn Chalkley giving a horse riders' perspective. Once completed the Parish Council will

present the results of the survey to the authorities responsible for rights of way (National Park and NYCC) and will work with them to make improvements where needed.

At the open meeting on 26 February a wildlife group was set up. This is co-ordinated by Angela Thomsett and will soon be starting a wildlife audit. There is still a need for more help and anyone

enthusiastic about wildlife in general is welcome to join in. Interested people should contact Angela Thomsett on 883224 or Alan Turner on 882310.

We are in contact with Forest Enterprise and are working to encourage them to expose the Hanging Stone through the felling of surrounding trees.
